RE: FIXING OF DATES FOR THE HEARING OF APPLICATIONS FOR ORDERS OF INTERLOCUTORY INJUNCTION IN WRITS Nos. J1/09/2024 AND J1/13/2023 INTITULED RICHARD SKY V PARLIAMENT OF GHANA & ANOR AND DR. AMANDA ODOI V SPEAKER OF PARLIAMENT & ANOR.

- 1. We write as solicitors for and on behalf of the first Defendant in the above intituled suits.
- 2. We refer to the applications for orders of interlocutory injunction in the above intituled suits served on the first Defendant. The said applications were filed on the 7<sup>th</sup> of March 2024 by the respective Plaintiffs in the said suits.
- 3. The applications were served on the first Defendant together with directive that they will be fixed for hearing fourteen (14) days after service of the said applications on the respondents to the applications, the first Defendant and the Attorney-General of the Republic of Ghana who is the second Defendant and respondent to the two applications.
- 4. We have observed that in an identical situation, in the case of *Rockson Nelson Este K. Dafeamekpor v The Speaker & Anor* in which two applications for orders of interlocutory injunction were filed on the 21<sup>st</sup> and 25<sup>th</sup> of March respectively, the registry of the Court fixed the said applications for hearing notwithstanding the fourteen days rule above referred to resulting in their determination on the 27<sup>th</sup> of March 2024 although the application in the said suit was served on the first Defendant together with the regular fourteen days directive.
- 5. The applications for injunction in the two suits above referred to, in our view, are identical to the *Rockson Nelson Este K. Dafeamekpor* suit filed later in time and share a lot in common with the latter said suit in terms of urgency and substance.

- 6. It will accordingly be appreciated if the parties are given a very early date to expedite the hearing of the applications pending before the Court.
- 7. We trust that as the applications raise matters of public interest, you will give our letter the attention it deserves.
- 8. Counting on your co-operation.
